Below is a transcript from a survey I participated in today. The aim is to share both the questions being asked and my answers to residents can be prepared when approached to partake.

The intent is to balance what many see as a biased survey and allow residents to consider their responses so we can give our views that we do NOT want a Sky Rail in our area.

This is just a quick transcription for now.. I will listen to it again later and see if I can formulate better answers for us to all use... but you now get the drift...

Question 1: Are you a resident at this address?

Answer 1: Yes

Question 2: How long have you lived here?

Answer 2: 14 years

Question 3: Have you heard that a number of the level crossing are being removed along the Frankston Line

Answer 3: Yes I have

Question 4: Overall would you say that you are a supporter or opposed to the removal of the Level Crossings on the

Frankston Line?

Answer 4: I support the removal of the Level Crossings

Question 5: Are you in favour or strongly in favour?

Answer 5: Strongly in favour?

Question 6: For what reasons?

Answer 6: Because I want to remove them and place the below ground

Question 7: For what reasons specifically?

Answer 7: I want the crossings placed below ground

Question 8: Yes, but what effect would that have?

Answer 8: I want the crossings placed below ground

- I asked him if he could specifically add this to his survey
- He said he could but did seem to be able to!

- He then added my response.

Question 9: Is that (my desire to have the crossing removed) because of noise or what?

Answer 9: Because of the amenity of the area.

At this point the survey stalled as I asked him a bit about the approach.

I asked him if the questions were all closed or if there were options to add additional comments

Response A: He said there was both closed options and open free text fields we could add our questions.

There are about 10 questions with only 2 or 3 having free text answers

___ I asked him for a copy of the questions, which he said would be sent to me...

Response B: But then he fumbled to find an email address for me to follow him up on

So I asked him who he was conducting the survey for

Response C: and said the "Level Crossing Track Removal Authority".

I corrected him and told him it was the LXRA... but he was pretty close.

o I asked him:

"What has been the brief you have been given when you come out?

Response D: Just set questions.

Response E: Yes, just set questions.

I asked him if he had any training in interview techinques, to which he replied

Response F: No.

What area are you covering?

Response G: Everywhere south of Mordialloc

Are you targeting specific houses **Response H:** We have set areas

.... How far back do you go

Response I: Not sure but it pretty expansive.

Question 10: In your opinion what would be the benefit to the local community of the removal of these crossings? **Answer 10:** I think they need to be placed below ground,

the benefits are to improve the amenity of the area.

Question 11: By "amenity" (he struggled to turn the question around to get me to expand) ..do you mean convenience?

<u>Answer 11:</u> Convenience ...aesthetics... reduce the noise, improve the health aspects, make it easier to get around, improve the general look and vibe of the suburb,

Are they all closed questions.

Response J: Yes, they are all closed.
