Victorian Government housing plan released

On Monday, Victorian Treasurer Tim Pallas released the affordable housing plan '[Homes for Victorians](#)'. This includes several recent announcements, including the \$1 billion fund to grow social housing announced last month, as well as new initiatives. The sections that will have most impact on homelessness include:

- [\\$1 billion social housing fund](#) - this fund will operate as a 'future fund' with the \$1 billion of capital invested in equities (shares). The fund will generate \$70-\$80 million in annual dividends in perpetuity for both new build and headleased social housing. Community housing agencies seeking grants from the fund would need to participate in the Housing Register. New rules for agencies participating in the register include the requirement that they allocate 75% of vacancies to priority applicants. [Read our full analysis here](#).
- [\\$1 billion social housing loan guarantee and \\$100 million revolving loan fund](#) - these will decrease the cost to community housing of borrowing money for new social housing
- [\\$109 million over five years to address homelessness](#) and [\\$152 million housing blitz over three years for family violence](#) - released last year, these packages provide new emergency accommodation, rental subsidies and support across a range of homelessness services. - [\\$30 million over three years to upgrade rooming houses](#)

We encourage you to explore the full plan, which also includes strategies to lower the cost of home ownership for first home buyers, the introduction of a 'vacancy tax', and some small scale pilots of inclusionary zoning. [You can read our media release here](#).

Speak up against proposed homeless by-laws

The campaign to stop proposed City of Melbourne by-laws that would ban camping in the CBD and inner Melbourne continues to gain momentum.

The current focus is on getting as many [submissions](#) as possible in via Council's community consultation process before the deadline of Friday 17 March. We would encourage you and any organisations you are part of to put in a [brief online submission](#) highlighting both the harm of these proposed laws for people sleeping rough, and providing examples of the lack of housing options that results in rough sleeping.

This involved building a multi-story boarding house in the outer suburbs with hundreds of rooms and relocating people sleeping rough. To encourage homeless people to accept the accommodation, Tom proposed reintroducing vagrancy laws to enable prosecution of any one who remained on the street.
