PRESIDENT'S REPORT

There have been a lot of positive changes around the creek over recent months. There are more in the future. As a summary of changes in this calendar year we've seen:

- Reconstructed footbridges at Beach Street, Fiocchi Avenue and Allawah Avenue in Frankston by Frankston City Council;
- Reconstruction of the concrete retaining wall between Beach and Wells Streets;
- Restoration of the walking track between Armstrongs Road and Station Street in Seaford;
- Clearance of a massive stand of succulents by the creek bank in Armstrongs Road;
- More indigenous plantings at Seaford Park;

In ensuing months we can expect to see:

- Informational signage around Seaford Park;
- A new footbridge at Beckwith Grove with improved access for users.

Lots of physical things are happening and hopefully that will continue; but the KCA needs more volunteer support. We are a voluntary organization so without volunteers we cease to exist. Some of the points above feature elsewhere in this newsletter. Please read them, but beyond that become actively involved. One working bee for 2 or 3 hours per month isn't a huge commitment.

BECKWITH GROVE PEDESTRIAN BRIDGE

The KCA is delighted to advise that on Monday 8th August 2016 the Councillors of Frankston City Council unanimously approved the reconstruction of the Beckwith Grove pedestrian bridge on a "like for like" basis. The CEO, Dennis Hovenden, indicated that the bridge would be built as a priority this financial year. From his comments the KCA is optimistic that this rebuild will be completed before the peak summer usage period.

It is fair to say that local residents were the main movers and shakers in helping secure the reconstruction of the bridge. They organized a petition with some 383 signatures in favour of rebuilding the bridge. This is a great outcome for the Seaford community and demonstrates what can be achieved with a positive approach to solving problems. We now have a new bridge with a predicted life span of 50 years to be built in the very near future.

78-83 Nepean Highway, Seaford

We would like to take this opportunity to bring you up to date on KCA's recent application to the Victorian Civil and Administrative Tribunal (VCAT) saga, objecting to Frankston City Council's decision to allow a development at 78-83 Nepean Highway in Seaford, with a frontage of 100 metres and containing 157 apartments, to proceed.

Taking this action was not an easy decision to make: the committee estimated it would cost KCA \$5,000; we knew it would consume an enormous amount of our volunteer time (between 200 and 250 hours); and that it would be what the members of KCA and local residents would have wanted us to do. Nevertheless we went ahead with our Application which was heard over three days, one day for a Mediation Conference, at which we were allowed to present our Statement of Claim and two days for hearing the arguments for and against the proposed development.

The Tribunal handed down its 41 page decision on 4 July, effectively giving the green light to the proposal. However a number of arguments put by KCA during the application process did bear fruit: amended plans were submitted which reduced the number of apartments 157 to 140, still a large number but the result was to allow for the removal of part of an upper level on the creek elevation of the building and to enable larger balconies to be provided than originally designed. KCA had also been in correspondence with Melbourne Water on flooding issues, with the outcome that MW (who couldn't seem to make up their minds whether to allow the development to proceed as it stood or to object) ended up requiring some fairly stringent caveats to be included in the titles to the dwellings. The VCAT Members also required best practice to be followed in the management of Acid Sulphate Soil which, if disturbed during construction, could release sulphuric acid into the waterway.

So, although we didn't achieve what we had hoped for, we made a stand and acquitted ourselves (a quartet of retirees!) reasonably WELL. The whole proposal was a complex one and because of that the Members have given the developer three years from the date of their Order to start construction and five years in which to finish it. We also understand that Frankston Council has since removed from its draft Planning Scheme higher density developments in Seaford between the Nepean Highway and Kananook Creek.
