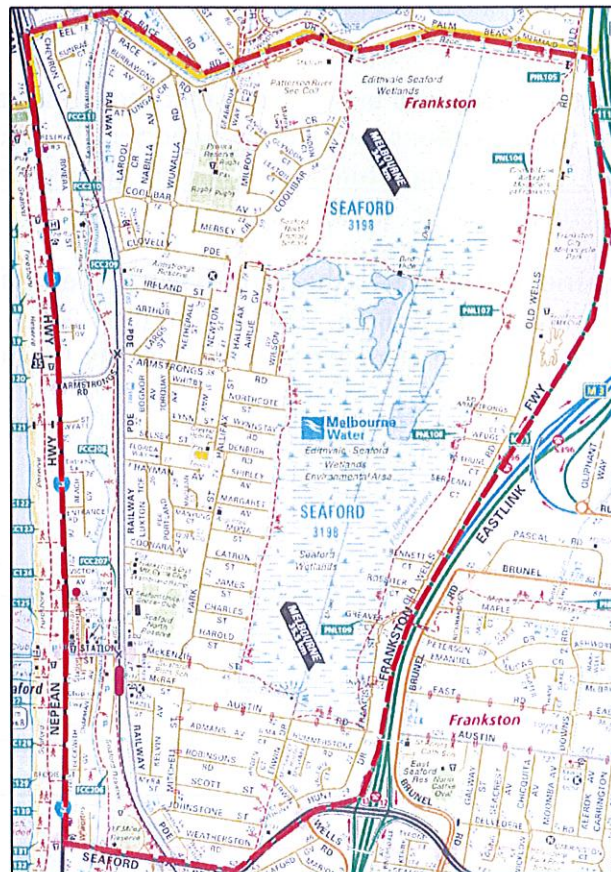

### LOCAL AREA TRAFFIC MANAGEMENT (LATM) STUDY – SEAFORD PRECINCT

Frankston City Council is undertaking a Local Area Traffic Management (LATM) study in Seaford to improve traffic management and road safety within the area. Council has engaged O'Brien Traffic, a traffic engineering and transport planning consultancy firm, to assist with the study.

#### What is an LATM Study?

An LATM study is a process to identify existing traffic and road safety issues and develop recommendations to improve safety, access and amenity, deter through traffic, and encourage walking and cycling in the study area. The Seaford Precinct study area is bounded by Eel Race Road, Frankston Freeway, Mornington Peninsula Freeway, Seaford Road and Nepean Highway, as shown below.



## The LATM Process

The first step in the LATM process is the identification of traffic and safety issues. This will be undertaken through the collection and analysis of data, together with information received from the community through the attached survey questionnaire.

Following the identification of issues, a draft traffic management plan will be developed and there will be further consultation with the community.

## Community Participation

Community participation is essential in identifying existing traffic issues in the local area. If you have any concerns relating to traffic, road safety, pedestrian or cyclist issues, you are strongly encouraged to complete the attached questionnaire and return it to Frankston City Council's Engineering Services Department by **Tuesday 6<sup>th</sup> November 2018** using the enclosed 'Reply Paid' envelope, or scanning and emailing to [EngServices@frankston.vic.gov.au](mailto:EngServices@frankston.vic.gov.au).
